

AN ORDINANCE ESTABLISHING THE BOUNDARIES  
OF THE FOUR WARDS IN THE CITY OF BARLING, ARKANSAS

BE IT ORDAINED AND ENACTED BY THE BOARD OF DIRECTORS OF THE  
CITY OF BARLING, ARKANSAS, THAT:

SECTION 1: The decennial census of the City of Barling has established that the wards of the City of Barling need to be redrawn in order to insure proper representation for all citizens of the City of Barling.

SECTION 2: Ward 1 shall be as follows:

Beginning at the NW corner of Fort Street and Lock and Dam Road, North to "K" Street, West to 5th Terrace, South to "H" Street, West to 9th Street, South to "F" Street, East to 8th Street, South to Fort Street, then East to the beginning point, at Fort Street and Lock and Dam Road.

SECTION 3: Ward 2 shall be as follows:

Beginning at the SE corner of Strozier Lane and Fort Street, East to "H" Street, East along "H" Street to 9th Street, South along 9th Street to "F" Street, East along "F" Street to 8th Street, South along 8th Street to Fort Street, then East along Fort Street to the city limits, then Westerly along to city limits boundary line to the West boundary, then North to boundary, then East to Painter Lane, North to the railroad track, East along railroad to Strozier Lane, then North to the beginning point, at Strozier Lane and Fort Street.

SECTION 4: Ward 3 shall be as follows:

Beginning at the NE corner of Strozier Lane and Fort Street, North to 15th Terrace, then along 15th Terrace to "N" Street, then along a line North to the city limit boundary line, then East and North along the city limit boundary line to the East city limit boundary line, near Lock and Dam Road, then South along the boundary to "K" Street, then West to 5th Terrace, South

to "H" Street, West to Fort Street, then West along Fort Street to point of beginning, at Strozier Lane and Fort Street.

SECTION 5: Ward 4 shall be as follows:

Beginning at the NW corner of the city limit boundary, East along the boundary line to the line from 15th Terrace North to the city limit boundary. South along this line to 15th Terrace, along 15th Terrace to Strozier Lane, South along Strozier Lane to the railroad track. West along the railroad tract to West city limit boundary line. North along this boundary line to point of beginning.



SECTION 6: All Ordinances in conflict with this Ordinance are hereby repealed. Ordinance No. 121 is specifically repealed.
